- 5. Consent form/ NOC must be signed at Visa Window. In case of single parent court custody documents of the child are also required to be submitted alongwith the application.
- 6. Visa will be refused on furnishing any false information.
- 7. Signature wherever are required on application form must be with blue ink.
- 8. If applicant unable to visit the Consulate for interview after twice upon calling, his application will be rejected.

- 10. If applicant is an employee, he will attach NOC from company if he is in partnership so he will provide copy of Trade Licence.
- 11. Birth certificate copies of children must be attached with application if their parents are applying their visa.
